- An electric Toyota Proace Matino campervan by Wellhouse Leisure, worth £65,000, is part of a 'text-to-win' competition for BBC Children in Need's 2021 Appeal.
- The campervan has a 75kW battery and sleeps four people. Its specification includes: kitchen with fridge, sink and cooker, two double beds, a pop-up roof, LED mood lighting, programmable heating, a 150W solar panel, metallic paint, alloy wheels, sat-nav, lithium leisure battery, sliding rear seat and twin-swivelling cab seats.
- The campervan is part of a prize package that also includes:
- two tickets to see Adele in concert.
- one year's insurance from campervan and motorhome insurance specialists, Caravan Guard (terms and conditions apply).
- *Wellhouse Leisure is leading UK campervan converter - ISO 9001:2008 certified.*

An electric Toyota Proace Matino campervan by Wellhouse Leisure, worth £65,000, is included in a 'text-to-win' competition for BBC Children in Need's 2021 Appeal.

Last year, a similar campervan from Wellhouse Leisure raised over £1.1 million as part of a prize package for BBC Children in Need's 2020 Appeal.

The campervan is part of a prize package that includes two tickets to see Adele in concert, plus 12 month's insurance from the campervan and motorhome insurance specialist, Caravan Guard worth up to £1,000.

The Toyota Proace Matino by Wellhouse Leisure is a four-berth campervan with a luxury specification for comfortable staycations at any time of year. It has a kitchen with fridge, sink and gas cooker, a rear seat that unfolds to become a double bed, a pop-up roof containing another double bed, a programmable heater to keep the interior warm and cosy, plus a 150W solar panel and lithium leisure battery. Electronic gadgets can be charged using the 12v or 240v sockets and USB points, plus, for extra privacy, there's dark tinted



rear windows.

This campervan is also easy to drive and park anywhere. It is 4.95 m (16.24 ft) long and 1.98 m (6.50 ft) high, so will fit in most car parks and parking spaces, making it ideal to drive to work every day, to the shops or off on a roadtrip adventure. It comes with sat-nav, cab air conditioning and a 75kW electric battery.

Inside, there's plenty of room for four people and any gear, such as bikes or other leisure kit. To maximise the loadspace when travelling, the rear seat can be moved forwards (to also bring rear passengers nearer to the driver); then, when camping, the rear seat can be moved backwards to maximise living space. Both front seats can swivel to face the rear to create a sociable lounge area.

The prize draw opened from 10:00 am, November 19th, 2021 and runs until 11:59 pm, November 28th, 2021 (tonight). Full terms and conditions, and details of how to enter the competition are available at: **[Terms and conditions](#)**.
